1 I, Joe Linneman, hereby declare as follows:

2 1. I am over eighteen (18) years of age, and I am a resident of Oregon House, CA. I have  
3 personal knowledge of the facts set forth herein, and, if called as a witness, I could and would  
4 competently testify thereto.

5 2. I am one of Defendant/Respondent North Yuba Water District's ("NYWD") customers  
6 for agricultural water.


7 3. I am entitled to two (2) miner's inches (mi) of water from April 15 through October 15  
8 annually. I use the water to irrigate my orchards, pastures, and domestic gardens and to maintain a  
9 perimeter of green vegetation around my buildings for the purpose of fire suppression.

10 4. I applied and paid for my irrigation allocation in early March of 2021, and was told  
11 approximately one month later that there would be no delivery of irrigation water during the 2021  
12 season.

13 5. I am aware, however, that other water districts in the same area are making deliveries to  
14 their customers.

15 6. As a result of North Yuba Water District's refusal to deliver water to its customers, I  
16 am forced to use my well for the entirety of my water needs. This has cost me thousands of dollars for  
17 well operation, and continues to do so.

18 I declare under penalty of perjury under the laws of the State of California that the foregoing is  
19 true and correct and that this declaration was executed in Fresno, California on April 26, 2021.
